Meeting Information

IEEE Virtual Reality is the world's premier international technical conference on all aspects of virtual, augmented, and mixed reality. It has been held each year since 1993. Attendees come from around the world, and include researchers and developers from industry, government, and academia. IEEE VR 2007 will be held in the Hilton Charlotte City Center in Charlotte, North Carolina. VR 2007 will be colocated with the second IEEE Symposium on 3D User Interfaces (3DUI 2007). Weekend activities (Saturday 10 March – Sunday 11 March) will include 3DUI, VR workshops, and VR tutorials, as well as an exhibits reception on Sunday evening. Weekday activities (Monday 12 March – Wednesday 14 March) will consist of the main VR conference program.

Space Assignments and Fees

Purpose

The purpose of all exhibits is to inform meeting participants of the types and nature of the products displayed related to applications in Virtual Reality and to provide information and explanation concerning related products and services.

Space Assignments

The following rules and regulations governing the exhibit under the auspices of the IEEE Virtual Reality Conference are part of the application for space and constitute a contract between the Exhibitor and the Conference. They have been formulated in the best interest of the Exhibitor and full cooperation of the Exhibitor in their observance is asked. Any detail not specified is subject to decision by the Chair of the Conference. Since exhibition space is limited assignments will be based on the date the application and the payment is received.

Space Selections

The Exhibitor agrees to accept the space assigned. The application, along with full payment of space, should be submitted to the conference exhibition office by **1 February 2007.** The Conference reserves the right to modify the designated exhibit space in the event a change in the original assignment is necessary.

Contract for Space

The acceptance of the application by the IEEE Computer Society and the full payment for rental charges constitute a contract. A completed application for space with full payment and all requested information must be submitted by mail or facsimile. Facsimile applications must include a credit card number, expiration date, and signature. **Telephone requests will not be honored.**

Full payment **MUST** accompany the application for space. No application will be processed without remittance of full payment. Deadline for initial space assignments is **1 February 2007**.

Cancellations

Exhibitors are requested to notify the Conference Services Department of the IEEE Computer Society of cancellations by physical mail, fax or by e-mail. Cancellations are not effective until notice has been received in writing (p-mail, fax or e-mail) by the Conference Services Department of the IEEE Computer Society.

Space reductions are considered cancellations and are subject to cancellation fees. It is understood that the IEEE Virtual Reality Conference reserves the right, at its option, to reassign a cancelled booth regardless of the cancellation rate assessed.





In the case that the conference is not able to assign space to an exhibitor all payment received so far from the exhibitor will be reimbursed.

Refunds

The date on which the Exhibitor's written notice of cancellation is received will be the official cancellation date. Cancellation of space by 27 Feb 2007 will result in 50% refund of registration fee. No refunds will be granted after 27 February 2007.

Failure to Occupy Space

Any Exhibitor failing to occupy space is not relieved of the obligation to pay full rental price for space. The Conference shall have the right to use exhibit space as it sees fit.

Sharing Space

Subletting of space is not permitted.

Furnishings

The Conference will provide a table and two chairs.

Signs

A 7" x 44" I.D. sign (b/w) will be furnished to each exhibitor by the Conference.

Badges and Staffing

Each exhibiting company is limited to ten (10) complimentary printed representative badges per booth. Exhibits must be staffed during show hours. Please note that you will be in violation of regulations if the exhibit is not staffed. Identification badges may be picked up at the registration desk. Badge exchange between exhibitor representatives is not permissible.

Operation of Exhibits

The management reserves the right to restrict exhibits which because of sound, method of operation, materials, content or any reason are objectionable, and also to prohibit or evict any exhibit as a whole.

Size of Exhibits

Exhibits must be arranged so as not to obstruct the view or otherwise interfere with the displays of other Exhibitors. This restriction includes person(s), things, conduct, printed material or anything of a character which may be objectionable to the exhibit as a whole. In the event of such restriction or eviction, the IEEE Computer Society is not liable for any refunds, rentals or other exhibit expenses.

Reservations at the Hilton Charlotte Center City must be made by 5:00pm EST, Thursday, 15 February 2007.

Violations

Exhibitor agrees with IEEE that IEEE shall not be liable for any damage or liability of any kind or for any damage or injury to persons or property during the term of this agreement, from any cause whatsoever by reason of use, occupation and enjoyment of exhibit space by Exhibitor or any person thereon with the consent of Exhibitor and that Exhibitor will indemnify and hold harm less IEEE from all liability whatsoever, on account of such damage, or injury, whether or not caused by negligence of or breach of an obligation by Exhibitor or its employees or representative.
